
SUBJECT: NOTICE UNDER SECTION 18/19 OF RIGHT TO INFORMATION ACT, 2005.

Sub: CIC Notice under section 18/19 of RTI Act, 2005.

With reference to your Appeal dt.27.06.2011 to CIC, it is to advise you that:

- (i) Your original RTI Application dt. 14.12.2009 was replied to on 14.01.2010.
- (ii) Your appeal dt. 19.01.2010 to the Appellate Authority was replied to on 16.02.2010. It was brought out in this reply that the last occasion when leave reserve posts in Junior Scale were created, was in 1980, when 91 posts were created. A copy of Board's sanction No.80E (GC)12/8(L&D) Reserve dt. 31.03.1980 was also enclosed to the reply. It was also brought out that no records relating to creation of earlier posts could be traced. You were also advised to visit Board's office for perusal of available papers, if necessary.
- (iii) Thus, your application dt. 14.12.2009 & Appeal dt. 19.01.2010 were replied to in time, on the basis of available information in the matter.

- (v) In the meantime, your fresh application dt. 14.09.2010, item 2 of which was on the same subject viz. leave reserve posts, was replied to on 22.10.2010. A copy of Board's letter No.80E(GC)12/8(L&D)Reserve dt. 31.03.1980 and copies of notings from the above mentioned file were enclosed as Annexure-II&III to the reply. Your appeal dt. 24.12.2010 was also replied on 11.01.2011 reiterating that information available on creation of leave reserve posts has already been furnished. A copy each of letter dt. 31.03.1980 & notings are again enclosed.
- (vi) Another application dt. 24.12.2010 on the same subject was also replied to on 01.02.2011 reiterating the position and advising you to visit Board's office, if desire to scrutinize the records. A copy of the reply is enclosed.
- (vii) Another application dt. 25.07.2011 on the same subject has also been replied to on 25.08.2011, a copy of which is enclosed.

2. It may be appreciated that whatever information is available, has already been furnished to you and there has been no denial of information.
